Subject: Release of funds for various development works in the villages of, Distt. Sonipat under Special Development Works in Villages (Normal Plan) Scheme during the current financial year 2018-19 (Plan).

The Governor of Haryana is pleased to accord the sanction for release of funds amounting to ₹ 2,20,45,000/- (₹ Two Crore Twenty Lac Forty Five Thousand Only) as Grant-in-aid to Gram Panchayat of District Sonipat for various development works in the villages (Name of Villages alongwith Suggestive list of works is enclosed at Annexure 'A') under the Special Development works in villages Scheme (Normal Plan) during the current financial year 2018-19.

The Govt. has also decided that the Director Panchayats, Haryana will be the drawing and disbursing officer of the said amount being allocated to Gram Panchayat of district Sonipat. He shall draw the amount from Govt. Treasury and deposit the same in the bank accounts of concerned Gram Panchayats of district Sonipat as per the list enclosed.

The sanction is subject to the following conditions:-

1. That in compliance of instructions issued vide memo no. DFA-3-2017/63435-533 dated 07-06-2017 and DFA-3-2017/69692 dated 30.06.2017, the funds shall be provided directly to the Gram Panchayats.
 2. That the work to be executed, shall be identified by the concerned Gram Panchayat by passing a resolution by majority.
 3. That the work shall be got done as per Haryana Panchayati Raj Finance, Budget, Accounts, Audit, Taxation and works Rules and instructions issued from time to time.
 4. That after completion of the work, the utilization certificate of the grants must be sent within time.
 5. That the Gram Panchayat would start the work as early as possible after observing the formalities and ensure the timely completion of the same.
 6. As soon as the Gram Panchayat concerned accord administrative approval, if any, for a specific work against the sanctioned amount, the detail of the same be conveyed to this office within a week thereafter.
 7. The works should be undertaken strictly as per guidelines conveyed vide letter No. PRA-1-2009/6650-70, dated 19.02.2009 whereby the Scheme of Special Development Works was issued.
 8. The amount under SCSP Component should be utilized for the benefit of Scheduled Castes population.
 9. That before start of work it shall be ensured that the works/projects being undertaken are covered under the guidelines/instructions issued by the State Government from time to time and funds have not been sanctioned earlier under any scheme for the same work/project.

10. The Gram Panchayats is advised to execute the work strictly in accordance with the guidelines issued by the Government from time to time.
11. The GP, by majority shall pass resolution for issuing administrative approval of works.
12. Before start of execution of work proper estimates of the works be framed and technical approval be obtained from the competent authority.
13. The grant is further released with the condition that if sewerage work is to be started within the current financial year, the works be taken up afterwards

The expenditure involved will be debited under major head code P-01-32-2515-51-101-83-51-(43) under 'Special Development Works in Villages scheme' for the year 2018-19.

Revised sanction will be issued in case the scheme is modified at any stage.
